Most Common Types of Forklift Injuries

As you may already be aware, forklift accidents have the capability of causing serious accidents and there are many different kinds of injuries that may occur in this event. Each injury is different and needs to be brought to the attention of a medical professional. Even with treatment, you may experience pain and discomfort even years after your accident. The most common types of forklift injuries include:

- » Being crushed
- » Need for amputations
- » Broken bones and fractures
- » Degloving

There are varying causes for forklift injuries and they each pose their own hazards. It is often because people trust their machinery, and have no reason not to, that they get hurt. Accidents are always possible and it can be devastating when they happen. Here are the top reasons why and how people get hurt when there are forklifts involved. They include:

- » When a forklift is overturned. This typically happens when there is negligence operation of the forklift. If someone goes too fast, turns too quickly, or picks up a too-heavy load, the forklift can overturn. A crushing injury would often be seen in this type of forklift accident.
- » Accidents often happen when workers are required to be raised and unload on the forklift. Falling accidents happen when these scenarios go awry.
- » Forklifts, like any other moving and operated machine, can experience collisions. There are many factors as to why a forklift would clear and they all involve negligence to properly maintain the workplace. If a crash happens, a host of injuries can plaque those of which it ails.

There are certain scenarios that make an accident more likely to happen. If there are badly kept surfaces, then there is a more likely chance of the forklift overturning. If the shelves are too high and the load is too heavy, and workers are required to unload that in an unsafe environment, people can get hurt. Negligence puts forklift operators at risk of injury.



IMPORTANT TECHNICAL ASPECTS TO A FORKLIFT ACCIDENT CASE

The usage of a forklift is strictly maintained by OSHA. These are very powerful machines and are supposed to be operated with great care. There are safety pre-

cautions and regulations which decide who is permitted to operate a forklift and why they will be allowed to do so. For example, you need to be at least 18 years old to operate a vehicle, and you need to be will trained and certified.

OSHA gives very detailed requirements and standard guidelines to who they allow to operate a forklift. There rules are very important. They exist to prevent injury. They have put in protection regulations to help those who could


potentially be hurt by a fall. These regulations include harnesses, guardrails, and protective equipment.

How Do I Pick the Right Attorney?

What Mistakes Should I Avoid Making?

That is very important in order to make a documentation of the accident and to preserve evidence. Another mistake that we see is that they don't seek legal advice or select proper attorneys that specialize in forklift accidents, which is important because they can advocate in the best way possible for you.

How Much is This Case Worth?

There are several questions that must be answered when determining the value of a forklift accident case. One of them is, what is the extent of the injuries? The second factor you need to look at is how and why the accident happened. Third is the amount of insurance that the defendant is going to carry.

There are certain regulations that apply to warehouses or workplaces where forklift accidents may happen. There are specific federal and state regulations that may apply to the forklift driver. You must look at all of that to determine what the value of the case is. You won't know the answer to that question until you get a lawyer who has experience and can investigate all the factors that happened to give you a better idea what the value of the case is.



How Is My Case Different?

I had a young man that came in the other day who was involved in a forklift accident. One of the questions he asked was how his forklift accident was different from other types of accidents. One of the ways that they're different is that there are specific regulations that apply to forklift drivers and the companies who train forklift drivers that's not going to be typical in most situations. The other way that forklift

accidents are different is that the injuries are typically to be a lot more serious because of the type of equipment involved.

How Long Will It Take to Settle?

The length of time it takes to resolve a forklift accident can be anywhere from 18 months to two years, or sometimes even a little longer. That's because of several factors. One factor is the court docket: how many cases does a judge have in front of you that are still waiting?

The other thing is how fair and reasonable an insurance company wants to be with you. It's within their control as far as if they could resolve the case early or

way down the road. They're the ones that hold the cards as far as if and when they're going to be fair.

The other thing that will also come into play is your healing process. We're not going to resolve a case until we're sure that you've reached maximum medical improvement. Then, at that point in time, we can look at everything you've gone through and all the harms and losses that you've suffered to put a value on your claim. We then take that to the insurance company and figure whether or not they're being fair with you, and what we're going to have to do to get that fairness for you.

Do I Need to Report My Injuries?

The other day, we had a client come in who had been involved in a serious fork-lift accident. He wanted to know should he have reported the injury to management. The answer is always yes — you should always report your accident to management.

Without reporting the incident, you will not have proper documentation of the accident and an official record of what happened. It's also good to preserve evidence of the accident. It will be very beneficial to your claim in the future. It's also extremely important that you contact an attorney right away.

Should I Speak to the Insurance Company?

The other day, we had a client who had recently been involved in a forklift accident and wanted to know if it would be a good idea to talk to the insurance companies that were contacting him.

Typically, it's not a good idea to talk to insurance companies. Why? Because they're not there to protect you. They are there to protect their insured. They're not going to do anything to help you. In fact, they might even use what you say against you in the future.
